#### **INSTRUCTIONS FOR BIDDERS**

#### 1. **General**

- (a) The Tenderer shall quote his rates on the PRICE SCHEDULE.
- (b) The Tender shall be accompanied by a Certified True Copy of the Power of Attorney as per new enactment being enforced, in favour of the Signatory of the Tender documents. In case the Signatory himself is the Sole Proprietor, an Affidavit on Stamp Paper of appropriate Value to this effect stating that he has authority to bind the Firm in all matters pertaining to Contract including the Arbitration Clause, shall be attached. The Person signing the Tender on behalf of another Partner(s) or on behalf of a Firm or Company shall attach with the Tender a proper Power of Attorney duly executed in his favour by such other Person or by all the Partner(s) or in accordance with Constitution of the Company in case of Company, stating that he has authority to bind such other Person(s) or the Firm or the Company as the case may be, in all matters pertaining to the Contract including the Arbitration Clause.
- (c) Even in case of Firms or Companies which have already given Power of Attorney to an individual authorizing him to sign Tender and Contract documents on behalf of the firm and in pursuance of which Tender are being signed by such Persons as a routine, a Fresh Power of Attorney duly executed in his favour by all Partners or the Firm stating specifically that the Person has Authority to bind such Partner(s) or the Firm or the Company as the case may be, including the condition relating to Arbitration Clause, should be submitted with the Tender, unless such Authority already been given to the Persons concerned by the Firm or the Company.

- 3. <u>Submission of Tender.</u> Tenders received after due date and time will not be considered for acceptance under any circumstances.
- 4. **Opening of Tenders.** During opening of Tender, Proprietor/Partner of the Firm or their Authorised Representative may be present. - 6. Period of Completion of refurbishing of Auditorium.
  - (a) The entire work under this contract described in Schedule 'A' shall be completed within **15 days** from the date of agreement. The contractor who is assigned the task of execution shall inform in writing in case of any delay in execution of work due to suggestive changes made by PMG. The extension of time period if any shall be given at the discretion of the SAMC.
  - (b) The date of completion for the purpose of issue of completion certificate by the Principal, Army Public School Amritsar shall be the date of taking over of works, in all respect, after obtaining satisfactory test results for items of works as applicable and as specified under respective items of Schedule 'A'. The defects liability period referred below shall commence from the certified date of completion of the work as per completion certificate issued by Principal, Army Public School Amritsar.
  - (c) <u>Defect Liability Period.</u> Should the PMG (Project Management Group) of Army Public School Amritsar, consider at any time during the resonation or reconstruction or prior to the expiration of a **SIX months** after the renovated washrooms work has been handed over by the contractor that any work has been executed with unsound, imperfect or unskillful workmanship, the contractor shall, irrespective of all kinds of payments done, at his own expense make good such works. The decision of SAMC (School administration & Management Committee), Army Public School Amritsar shall be final and binding.

#### SPECIAL CONDITIONS OF CONTRACT

- 7. This section lists out important conditions of the contract.
  - (a) <u>Minimum Wages Payable.</u> The contractor shall pay not lower than minimum wages for labour as fixed by the Government of India/State Govt whichever is higher.
  - (b) The fair wage will be deemed to be the same as the minimum wages payable as referred to above.
  - (c) The contractor shall have no claim whatsoever if on account of local factor and or regulations; he is required to pay the wages in excess of minimum wages as described above during the execution of work.
  - (d) During the currency of the work, the contractor is expected to adhere to the time schedule and this adherence will be a part of the contractor's performance under the contract. During the execution of the work, contractor is expected to participate in the reviews and updating of the works undertaken by the PMG, Army Public School Amritsar. These reviews may be under taken at the discretion of the Principal, Army Public School Amritsar. Any revision of the time schedule as a result of review will be submitted within two days, by the contractor to the Principal, Army Public School Amritsar who will approve after the scrutiny. The contractor will adhere to the revised time schedule, thereafter. In case of contractor not agreeing to revised schedule, the same will be referred to the Accepting Officer whose decision will be final, conclusive and binding.
  - (e) Contractor is expected to mobilize and employ sufficient resources to achieve the detailed schedule within the broad framework of the accepted methods of working and safety.
  - (f) No additional payment will be made to contractor for any multiple shift work or other incentive method contemplated by him in his work schedule, even though the time schedule is approved by the Department.
